Rio de Janeiro, 21 de agosto de 2018 – A brMalls (“Companhia”), maior empresa integrada de shopping centers do Brasil, vem, em cumprimento ao art. 12 da Instrução CVM n.º 358/02, comunicar que recebeu, no dia 21 de agosto de 2018, da GIC Private Limited (“GIC”), com sede em 168 Robinson Road #37-01 Capital Tower, Singapura, a informação de que:

- (i) no dia 17 de agosto de 2018, as participações societárias detidas pela GIC Private Limited, passaram a totalizar, 43.731.125 (quarenta e três milhões, setecentos e trinta e um mil, cento e vinte e cinco) ações ordinárias de emissão da Companhia, representativas de 5,007% do capital social da Companhia;
- (ii) o objetivo da participação de GIC Private Limited na Companhia é estritamente de investimento, não objetivando alteração do controle acionário ou da estrutura administrativa da Companhia;
- (iii) não foram celebrados, pela GIC Private Limited quaisquer contratos ou acordos que regulem o exercício de direito de voto ou a compra e venda de valores mobiliários emitidos pela Companhia.
