1. **Data, Hora e Local:** No dia 28 de junho de 2019, às 14h, os acionistas da BR Malls Participações S.A. (“Companhia”) se reuniram na sede da Companhia, na Avenida Borges de Medeiros, 633, 1º andar, CEP 22.430-041, na cidade e Estado do Rio de Janeiro.

2. **Convocação:** Convocação realizada em conformidade com as determinações do artigo 124 da Lei nº 6.404/1976 (a “Lei das S.A.”), mediante a divulgação de Edital de Convocação publicado nas edições dos dias 28, 29 e 30 de maio de 2019 do Diário Oficial do Estado do Rio de Janeiro e do jornal Valor Econômico.

3. **Presença:** Compareceram à Assembleia Geral acionistas representando 62,10% do capital social, conforme (i) assinaturas constantes do Livro de Registro de Presença de Acionistas; e (ii) boletins de voto à distância recebidos por meio da Central Depositária da B3 S.A. – Brasil, Bolsa, Balcão (a “B3”), pelo escriturador ou diretamente pela Companhia, nos termos da Instrução CVM nº 481/2009 (a “ICVM 481”). Presentes, ainda, o Sr. Frederico da Cunha Villa, Diretor Financeiro e de Relação com os Investidores da Companhia, a Sra. Helena Turola de Araujo Penna, membro do Conselho Fiscal da Companhia, e o Sr. Marco Antonio Hintz, representante da IAUD Auditores Independentes S/S.

4. **Ordem do Dia:** (1) Ratificar a nomeação e contratação da IAUD Auditores Independentes S/S como empresa responsável pela elaboração do laudo de avaliação, a valor contábil, dos patrimônios da Fashion Mall S.A. (“FMSA”) e da Classic Participações Ltda. (“Classic”) a serem incorporados pela Companhia; (2) Examinar, discutir e deliberar sobre o Laudo de Avaliação; e (3) Examinar, discutir e deliberar sobre a proposta de incorporação, pela Companhia, de suas controladas FMSA e Classic, de acordo com os termos e condições previstos no Protocolo e Justificação de Incorporações.

6. **Deliberações:** Após a leitura do mapa de votação sintético consolidado dos votos proferidos por meio de boletins de voto à distância (o qual ficou à disposição para consulta

dos acionistas presentes), conforme dispõe o artigo 21-W, parágrafo quarto, da ICVM 481, as seguintes deliberações foram tomadas:

6.1. Preliminarmente, por unanimidade, foi aprovada a lavratura da ata que se refere a esta Assembleia Geral na forma de sumário e foi autorizada sua publicação com a omissão das assinaturas dos acionistas, conforme faculta o artigo 130, parágrafos primeiro e segundo, da Lei das S.A., tendo sido registrados 226.329.782 votos a favor.

6.2. Os acionistas, por unanimidade, ratificaram a nomeação e contratação da IAUD Auditores Independentes S/S como empresa responsável pela elaboração do laudo de avaliação, a valor contábil, dos patrimônios da FMSA e da Classic a serem incorporados pela Companhia ("Laudo de Avaliação"), tendo sido registrados 523.377.355 votos a favor, nenhum voto contrário e 216.900 abstenções.

6.3. Os acionistas aprovaram, por unanimidade, sem reservas ou ressalvas, o Laudo de Avaliação, tendo sido registrados 523.377.355 votos a favor, nenhum voto contrário e 216.900 abstenções.

6.4. Os acionistas aprovaram, por unanimidade, sem reservas ou ressalvas, a proposta de incorporação, pela Companhia, de suas controladas FMSA e Classic, de acordo com os termos e condições previstos no Protocolo e Justificação de Incorporações, tendo sido registrados 523.377.355 votos a favor, nenhum voto contrário e 216.900 abstenções. Ficam os administradores da brMalls autorizados a promover todos os atos necessários às incorporações, incluindo o registro da troca de titularidade dos imóveis de propriedade da FMSA e da Classic que, juntamente com todos os demais bens, direitos e as obrigações das referidas sociedades, se tornarão de titularidade da brMalls.

6.5. **Encerramento:** Nada mais havendo a ser tratado, foram encerrados os trabalhos e lavrada esta ata, a qual, depois de lida e achada conforme, foi aprovada e assinada pelos presentes. Foram recebidas pela Mesa manifestações de voto em separado, inclusive abstenções, as quais foram devidamente recebidas, numeradas e autenticadas e ficarão registradas na sede da Companhia
